

When you were born, you were entered into a contract without your knowledge when you were only a few days old. By turning you into a corporation they're able to do business with that corporation they created, your birth certificate. It's a legal action corporation to corporation. Legal doesn't apply to a man or woman. Lawful applies to a man or woman, not the 'Person' they created as the corporation with the birth certificate. You were not aware of this 'Person' they created and neither were your parents.

You were not born this 'Legal Person,' but free and equal under the 'Law.' We have not entered into a contract with another man or woman. A corporation cannot enter into a contract with a living, breathing, human being. So they killed you, you're dead in the water as far as the corporation is concerned. When they created this 'Legal person,' they trespassed on you the baby, the man or woman. This 'Legal' paper does not apply to us unless we've entered into a contract with another man or woman, with full consent, and you understand this contract you've entered into.

They use the birth certificate to create other fictional identifications, corporations created in your name such as a driver's license or health card, your social security number.

You must understand what's going on. No man or woman has control over another man or woman, we are not 'Property' of another man or woman and no man or woman can administrate 'Property' without rights.

There was a trespass when we were born.

It was an 'Unlawful' capacity where they took you out of a 'Lawful' capacity to a 'Legal' capacity. They're not converting you, but this 'Legal Person' with an all capital-letter name.

Remember, you didn't create your birth certificate. It's not your I.D., it's theirs.

It's not your birth date, but the registration date that's important.

It's a 'Service' corporation. Take out the word 'Government' corporation, and insert the word 'Service' corporation. That's what they are. They're not government corporations, they're service corporations, no different than McDonald's or Burger King corporations.

It's from this 'Service' they claim ownership, and when you walk into a courthouse, they're all operating on this 'Public' fraud. It's a 'Public' courthouse, not a 'Private' courthouse, which means every 'Man and Woman' has a right to access it, and there is no 'Man or Woman' in that courthouse that can deny you access to seek the administration of justice. It's very important that we use the center of lines, and this applies to everybody the simplicity of this. 'Common Law' is common sense.

The bar is a 'Private' society. They don't represent you in a court, they re-present you in a court. They re-present you as this 'Legal' 'Person' created by the birth certificate.

Unless you have caused harm against another 'Man or Woman,' you cannot be 'Lawfully' charged with any crime.

The lawyers and judges are not there to represent you, they're there representing the system.

Once you enter into a courthouse in the right capacity as a 'Man or woman,' their paperwork arrives before you and they are acting under the presumption of control based on this 'Unlawful' conversion that has happened to us when they created this 'Legal' 'Person,' the birth certificate.

The documentations have your name in all capital letters, the corporation, and that lawyer can 're-present' you as trained as the corporation. Both lawyers have an oath to the court to extract as much money as they can from you under this fraudulent, 'Unlawful' system. It's a 'Service' that they are offering, but the 'Service' is a rigged casino, and once you realize this, you will not go in there under their capacity. You're going to enter under the capacity of a 'Man or Woman.'
