

# Dick Cheney Flees U.S. for New Zealand

On the day George W. Bush was arrested for treason and murder, his former partner in crime, Richard Bruce Cheney, also the target of a military arrest warrant, was at Wyoming's Jackson Airport boarding a CIA-sponsored Boeing 757 bound for New Zealand via an unknown refueling stop, said an Office of Military Commissions source speaking under promise of anonymity.

The military, he told Real Raw News, had hoped to enforce simultaneous arrests, Bush at his Crawford ranch and Cheney at his family's property in Jackson, Wyoming, but the man who has been called "the most powerful vice president in American history" had absconded by the time U.S. Marines arrived at his door with a "no-knock" warrant.

"We had the place under surveillance, and Cheney was there 12 hours prior. He must've been tipped off. We didn't know he had an escape and evasion plan mapped out," our source said.

Marines, upon entering the deserted and dark home, found a concealed "floor door" that opened into a 25'-diameter subterranean tunnel stretching several miles north from the property to a cave mouth near the Snake River, a few

miles from the airport. The tunnel was wide enough to accommodate vehicles, and the Marines reported seeing two golf carts, and fresh tire tracks leading into the distance. They traipsed through the tunnel and found at its terminus what our source called a "souped up golf cart" and nearby skid marks indicative of a helicopter touch down.

"We suspected then, and now know as fact, that he fled the home and was whisked away by a helicopter. We guessed it flew him to the airport, but there was zero evidence he was ever there. No security footage, no check-in. It was a mystery. And only recently did we learn that his CIA allies arranged his escape," our source said.

The draft dodger and alcoholic has undeniably strong ties to the Deep State-run Central Intelligence Agency. In 1974 Cheney unsuccessfully tried to have the Freedom of Information Act revoked on behalf of the CIA, and a year later helped undermine investigations of CIA scandals. He slowed the end of the Cold War in 1989, promoted the global hegemon role for the U.S. in 1992, hid his work with oil companies in 2001 to set energy policy, endorsed torture and warrantless surveillance in the 2000s, played a leading role in trashing Iraq and the Middle East from the Iraq invasion in 2003 to the present, mysteriously went whole days at the White House without his Vice President's office generating any saved e-mail, and presented a danger to civilians whether they were armed or not by shooting his hunting partner in 2006, ostensibly for the CIA. Not to mention his role in orchestrating 9/11.

In short, the military had good reason to seek his arrest. But the CIA apparently owed him favors.

"We found out the reason Cheney wasn't seen at the airport is that the helicopter deposited him on the runway where a gassed 757 was waiting for him. He boarded, and it took off immediately. We know it had to refuel somewhere, probably in the southern U.S., because a 757 can't travel from Wyoming to New Zealand on a single tank of gas. But our contact couldn't, or wouldn't, tell us where that was. But he was emphatic that Cheney is now in New Zealand," our source said.

In closing, he said the military has not abandoned its mission to bring Cheney to justice.

# Dick Cheney Arrested

Disgraced former Vice President Dick Cheney was arrested Christmas Eve while trying to discretely reenter the United States to spend the holiday with his daughters—Liz and Mary—at the latter’s home in Virginia, said a Judge Advocate General’s Corps representative speaking under terms of anonymity.

As Real Raw News reported previously, the 9/11 mastermind had on 11 November fled the U.S. for New Zealand after discovering, apparently, that he, like his former boss George W. Bush, was the target of a military arrest warrant. Bush was apprehended that night, but Cheney had a sophisticated escape and evasion plan that aided his getaway.

“JAG and OMC received actionable intelligence that Cheney was returning to the U.S. aboard an unscheduled and undeclared CIA Boeing 777-200 headed to Miami. When the intel came in, he’d already been in the air for some time, and the flight was scheduled to touch down sometime around 4:00 p.m., Christmas Eve. He was already halfway here, so we had only hours to get in motion,” our source said.

Without disclosing specific operational details, he said plainclothes U.S. Special Forces had staked out the airport in advance of Cheney’s arrival. At a quarter past four, spotters with binoculars saw the unmistakable profile of the twin-engine, widebody on final approach. It landed on Runway 9 but did not taxi to either of the airport’s international terminals, as is customary for flights arriving from overseas; instead, the plane taxied to and came to a

stop outside a maintenance hanger north of the terminals. The engines spooled down, and a pushback tug towed mobile ramp stairs alongside the jumbo jet. When the door opened, only one person deplaned. It was Richard Bruce Cheney.

Cheney immediately entered a black limousine with diplomatic license plates that had pulled up near the ramp stairs only seconds after he had left the plane.

“Special Forces had two choices: Take him there or tail the vehicle. They didn’t want to create a scene and chose to follow the limo,” our source said.

In civilian vehicles the SF team shadowed the limo several miles from the airport to an underground parking garage at the Hilton Miami Airport Blue Lagoon Hotel, ostensibly where Cheney planned to stay the night or switch vehicles to avoid potential pursuers.

Special Forces blocked the limo, trapping it motionless between their innocuous-looking Range Rovers, and then surrounded it with weapons drawn, ordering the occupants to at once exit the vehicle. The driver complied and handed over his credentials. He identified himself as Yusuf Hamza, a Pakistani national and CIA asset, claiming he was on a diplomatic assignment, transporting a VIP from Miami International to Miami Regional Airport. He said that he, his vehicle, and any passengers had full diplomatic immunity against searches, seizures, and arrests.

“Immunity revoked,” the SF commander purportedly told him.

When Cheney refused to exit the vehicle, SF lowered the plexiglass partition separating the driver and passenger compartments and held a pistol directly to his forehead.

“Cheney eventually got out, but not before giving the usual Deep State spiel: ‘Do you know who I am? I own you. Your lives are over.’ That sort of hype. Then he said he was just trying to get to Virginia to see his family for Christmas. Probably not the Christmas he wanted. One thing’s for sure, he’ll be spending New Year’s at Guantanamo Bay,” our source said.

Both Cheney and Hamza have been taken to a detention center for processing, our source said in closing.

A 3-officer panel at Guantanamo Bay convicted former VP Richard Bruce Cheney of treason and murder after hearing only two hours of testimony Tuesday morning.

Rear Adm. Darse E. Crandall of the U.S. Navy Judge Advocate General's Corps said in an opening statement that Cheney and the late George W. Bush were co-conspirators in the 9/11 tragedy and plots to criminally thrust the United States into unjustified wars. Their motives, he said, included destabilizing the Middle East, personally profiting from opium the U.S. military had seized in Afghanistan, giving the military an excuse to wantonly live-fire test novel weapons, and earning a hefty kickback from insurance money paid to Larry Silverstein, the American real estate mogul who owned the towers on the day they crumbled to dust.

As Cheney sat stone-faced behind the defense table, Rear Adm. Crandall showed the panel financial documents the military had acquired during its investigation into Cheney's past. Five million dollars, paid in five installments, was dispersed to an offshore Cayman Island bank account bearing the name "Eric Burchard," an anagram for "Richard Bruce," Cheney's proper first and middle names. The transactions took place between 11/7/2001-02/17/2002, long before Silverstein Properties Inc. received a 2bn settlement.

"We know with certitude that Eric Burchard is Richard Bruce Cheney; our investigation established this fact. The account was opened three days prior to 9/11 and had only the minimum balance needed to keep it open until Silverstein's money poured into it. Silverstein knew he'd get a huge payout, it wasn't the 7bn he wanted, but still. And the defendant, in opening the account, knew 9/11 would happen well in advance. If he has another explanation for taking the payout, we'd love to hear it," Rear Adm. Crandall said.

"Rot in hell," Cheney uttered with clenched teeth.

Additionally, Rear Adm. Crandall played the same audio tapes he had used to help convict George W. Bush, the ones Donald Rumsfeld had secretly recorded as he, Bush, and Cheney devised a plan to carry out 9/11 without being implicated. On them, Cheney told Bush "Not to worry" because he would "take care of everything."

"When we first spoke to detainee Cheney, he tried to put the whole thing on Bush, and when informed that Bush is, well, dead, he got quiet. He refuses to explain why he fled the country the night we caught Bush. JAG and the OMC believe Cheney's actions, the tapes, and his taking a payout from Silverstein prove beyond doubt that he is guilty of treason and, like Bush, must be held to account for the deaths the persons who perished in 9/11 and all American soldiers that died in Afghanistan and Iraq. We seek maximum punishment," Rear Adm. Crandall said.

In an unusual move, an officer on the panel requested to ask Cheney a question directly.

"Have you any remorse? Do you ever think of the people who've died, or what the lives of their friends and family must be like? Do you have guilt over the callousness of it all?"

"Have you ever seen the film *A Few Good Men*, with Jack Nicholson playing Colonel Jessup? He wanted to strengthen our country, and without admitting anything, the same is for me. Any actions I might've taken were in the name of protecting and strengthening the United States," Cheney replied.

Ten minutes later the panel reached a verdict: Guilty.

It endorsed Rear Adm. Crandall's recommendation that Cheney be executed for his crimes.

A date of execution is pending.

# Dick Cheney Hanged at GITMO

The Judge Advocate General's Corps and the Office of Military Commissions do not typically conduct "business" on Saturdays, but for Richard Bruce Cheney, they made an exception.

Cheney, who on 18 January was convicted of treason and murder and sentenced to death, was hanged at Guantanamo Bay Saturday morning before a quorum of military brass—Rear Adm. Darse E. Crandall and "White Hat" loyalists from other branches of the Armed Forces, excluding the National Guard and Coast Guard.

The execution, however, had a hitch. Cheney tried to cheat death when the pivoting door beneath his feet failed to open after Rear Adm. Crandall had given the "execute" command.

Unlike gallows of bygone days, which functioned mechanically with levers and pulleys, the apparatus at GITMO works electronically; an anonymous soldier pushes a button, and the door swings open.

When the door did not open, Cheney tried to invoke a myth of the Wild West stipulating that if gallows failed—rope breaking, for example—the prisoner would be set free, his sentence commuted.

“I should be released. Your machine broke. It was customary in the 1800s, that when a lynching went awry, for whatever reason, the condemned was released,” Cheney said as he stood atop the platform with his head in the noose.

“Unfortunately for you, this isn’t 1867 Cheyenne, it’s 2022 GITMO,” Rear Adm. Crandall said. “But if it were, we wouldn’t hang you. I think a duel at 20-paces would be far more gratifying.”

A soldier from the U.S. Army Corps of Engineers arrived in 15 minutes. He found a short in the wiring, which he repaired promptly with a portable soldering iron.

Unsurprisingly, Cheney began swearing and cussing, his voice rich with condescension, at Rear Adm. Crandall and the other officers in attendance, vowing his people would avenge his death.

“You’re about to be reunited with some of those people,” Rear Adm. Crandall said, and once more instructed the soldier atop the platform to press the button.

This time the gallows worked flawlessly. The door swung open, and Cheney dropped to his death. A physician on-scene pronounced him dead, and his body was sealed in a plastic bag.
